Any modifications to species or facility must be documented. If there is a change in ownership, 3 years inventory records must be provided, including complete inventory of fish, fish eggs or fish gametes at the time of transfer.

If this is an application for a new hatchery, please include a diagrammatic sketch of all aquaculture facilities, water supplies and effluent drainages. The name of the stream or body of water into which effluent from the hatchery is discharged or would possibly be discharged into in the event of flooding shall be provided. Any ponds shall be identified with a unique name or number and size in surface acres. This information, along with any additional remarks, may be provided on separate sheets.

A copy of a surety bond in the amount of \$500.00 is also needed to process application.

Applicant agrees that all fish, fish eggs or fish gametes must be inventoried and disposed of in a manner approved by the Department within sixty (60) days of a license revocation or renewal denial or failure to renew. After this sixty (60) day period, the Department may dispose of said fish, fish eggs or fish gametes in accordance with Chapter 51 of Game and Fish Commission regulations.
