



Wyoming Fishing Contest Permit Application

A permit is required for any event involving taking fish on any water of the state other than licensed fishing preserves, where:

1. Cash or prizes are awarded or an entry or participation fee is charged; **and**,
2. Fifty or more adults (18 years of age or older) or 25 or more boats participate on a given date.

Review the "FISHING CONTEST REQUIREMENTS" document prior to completing this application.

A completed application must be submitted at least **30 days** prior to the start of the contest. Applications will not be accepted more than one year in advance of the contest.
