- (ii) Per Wyoming Statute 23-2-303, a copy of the most current statutes or rules and regulations of the applicant's state of residence which shows that the state issues nonresident trapping licenses which authorize Wyoming residents to trap the same species for which residents of that state may be licensed to hunt or trap in that state.
