

# DIAMOND LAKE HUNTER MANAGEMENT AREA

Open **AUGUST 15, 2024 thru OCTOBER 31, 2024** for the take of **ANTELOPE only in hunt area 43** during specific season as published in the 2024 Game and Fish Commission Regulations

## GENERAL RULES:

- Each hunter must possess a valid permission slip while in the field
- Each hunter must display a valid vehicle pass in the window
- Leave gates as you find them
- Hunting by foot only
- Non-hunting, non-permitted persons may accompany a permitted hunter with a valid permission slip and do not possess a bow or firearm
- No camping and no littering—carry out everything you bring in
- Portable blinds may be used on a daily basis. Blinds must have owner's name and contact information affixed and the blind shall not be left in field overnight.
- GPS/Mapping Service is highly recommended when accessing this property

## RESTRICTIONS

- **NO shooting in the direction of wind-power facilities and personnel—remember high caliber rifles can shoot a long distance, read additional restriction when receiving a permission slip.**
- No take of ANY OTHER SPECIES (including predators) or any other activities (including collecting antlers) without landowner permission
- Preseason scouting is not allowed
- Driving on closed roads or behind closed area gates is not allowed
- Any commercial activity, including outfitting or guiding is not allowed
- Do not shoot in the direction of, or within 100 yards of, livestock or buildings
- Do not damage range improvements or harass livestock
- Camping on State Trust lands is not allowed
- No travel through HMA for the take of wildlife not listed on permission slip
- When road is wet or muddy - **DO NOT DRIVE ON THEM**, Motorized travel is restricted to highway and county roads

## DIAMOND LAKE HMA SPECIFIC RULES:

- You may only receive either a Diamond Lake or Laramie River HMA permission slip - not both
- [Access is only through the Sprague Road entrance to the Laramie River HMA. Then take the special condition road to the east side of the Diamond Lake HMA. No hunting is allowed through the Laramie River HMA.](#)
- Vehicle access on ESTABLISHED roads only
- No ORVs/Motorcycles allowed (in possession or use)
- Camping or campfires allowed only on federal lands accessed without crossing private property
- Permission slips are available only from the Wyoming Game and Fish Department (not from the individual ranches)
- One permission slip allows a hunter to attempt to take multiple antelope during the permitted time period, if the hunter has additional valid area 43 antelope licenses

### DEFINITIONS:

- **TAKE:** Means hunt, pursue, catch, capture, shoot, fish, seine, trap, kill, or posses, or attempt to hunt, pursue, catch, capture, shoot, fish, seine, trap, kill or possess.
- **Established road:** means any road or trail that has been graded or constructed to carry motor vehicles or on which repeated motor vehicle traffic has created well defined tracks
- **Designated road:** means only established roads that are marked with a white arrow sign as open to motor vehicles. Roads not marked with a white arrow sign are **closed** to motor vehicles.
- **Wet or muddy road:** all roads are closed when conditions are wet or muddy.
