STROUSS HILL HUNTER MANAGEMENT AREA-

Open <u>August 15, 2024 thru December 20, 2024</u> for the take of **Antelope** in hunt area 45 (except portions along western edge) and **Antlerless Elk** in hunt area 10, during specific seasons as published in the 2024 Game and Fish Commission Regulations

GENERAL RULES:

- Each hunter must possess a valid permission slip while in the field
- Each hunter must display a valid vehicle pass in the window.
- Hunting is by foot only.
- Leave gates as you find them. (Make sure top wire loop is secured below staple in gate post)
- Non-hunting, non-permitted persons may accompany a permitted hunter with a valid permission slip and do not possess a firearm.
- No overnight camping, campfires and dogs on HMA.
- GPS/Mapping Service is highly recommended when accessing this property.
- **No littering**—carry out everything you bring in.
- Access within closed areas (see map) is not allowed.

RESTRICTIONS

- No taking of ANY OTHER SPECIES (including predators) or any other activities (including collecting antlers, hiking, etc..) without landowner written permission.
- Preseason scouting is not allowed.
- Driving on closed roads or behind closed area gates is not allowed.
- Any commercial activity, including outfitting or guiding is not allowed.
- Do not shoot in the direction of livestock, roads, fences, windmills, stock tanks or buildings.
- Do not damage fences, range improvements or harass livestock.
- No travel through HMA for the take of wildlife not listed on permission slip.
- Portable blinds may be used on daily basis. Blinds may not be left in field overnight. (Owners name and contact information must be printed to outside of the blind)
- Permission slips are available only from Wyoming Game and Fish Dept. (Not individual ranches)
- On Private Property only, off-road vehicles (ORVs) may travel off established roads and behind road closed signs for game retrieval if such damage doesn't damage rangeland resources. (Firearms may not be carried on ORVs on the HMA) (ORVs are defined by Wyoming Statue 31-1-101)

The Strouss Hill Ranch HMA SPECIFIC RULES:

- One permission slip allows a hunter with more than one valid license to take multiple animals during their permission slip period. (ex. Multiple area 45 antelope licenses or multiple area 10 type 6 licenses)
- You may only receive either a **Strouss Hill** or a **X-Bar HMA** permission slip to take antelope. **Not Both**
- Anyone without Department permission or display the vehicle permission pass on their dash shall be subject to trespass charges.
- Access only during dates specified on permission slip for current year
- Drive on **established** roads only. Travel is restricted to county roads and highways when wet or muddy.
- Future hunting opportunities depend on hunter compliance with Ranch Rules as well as Game and Fish laws and regulations.

• CWD samples: Hunters are reminded the Department is collecting CWD samples from deer and elk.

DEFINITIONS:

- <u>TAKE</u>: Means hunt, pursue, catch, capture, shoot, fish, seine, trap, kill, or posses, or attempt to hunt, pursue, catch, capture, shoot, fish, seine, trap, kill or possess.
- Established road: means any road or trail that has been graded or constructed to carry motor vehicles or on which repeated motor vehicle traffic has created well defined tracks
- <u>Designated road</u>: means only established roads that are marked with a white arrow sign as open to motor vehicles. Roads not marked with a white arrow sign are **closed** to motor vehicles.
- Wet or muddy road: all roads are closed when conditions are wet or muddy.
