GENERAL RULES:

- Each hunter must possess a valid permission slip while in the field
- Each hunter must display a valid vehicle pass in the window
- Leave gates as you find them
- Hunting by foot only
- Non-hunting, non-permitted persons may accompany a permitted hunter with a valid permission slip and do not possess a bow or firearm
- No camping and no littering—carry out everything you bring in
- Portable blinds may be used on a daily basis. Blinds must have owner's name and contact information affixed and the blind shall not be left in field overnight.
- No tree stands or trail cameras allowed on HMA.
- GPS/Mapping Service is highly recommended when accessing this property

RESTRICTIONS

- No take of ANY OTHER SPECIES (including predators) or any other activities (including collecting antlers) without landowner permission
- Preseason scouting is not allowed
- Driving on closed roads or behind closed area gates is not allowed
- Any commercial activity, including outfitting or guiding is not allowed
- Do not shoot in the direction of, or within 100 yards of, livestock or buildings
- Do not damage range improvements or harass livestock
- Camping on State Trust lands or University property is not allowed
- No travel through HMA for the take of wildlife not listed on permission slip

PETERSON DRAW HMA SPECIFIC RULES:

- Vehicle must park in designated parking area's
- Permission slips are available only from the Wyoming Game and Fish Department (not from the individual landowner)
- One permission slip allows a hunter to attempt to take multiple species during the permitted time period (refer to Commission Regulations), if the hunter has additional valid licenses
- Be respectful of personnel that maybe working in the area and other hunters
- Limited areas to hunt please be respectful of other hunters that were there first

DEFINITIONS:

- <u>TAKE</u>: Means hunt, pursue, catch, capture, shoot, fish, seine, trap, kill, or posses, or attempt to hunt, pursue, catch, capture, shoot, fish, seine, trap, kill or possess.
- <u>Established road</u>: means any road or trail that has been graded or constructed to carry motor vehicles or on which repeated motor vehicle traffic has created well defined tracks
- **Designated road**: means only established roads that are marked with a white arrow sign as open to motor vehicles. Roads not marked with a white arrow sign are **closed** to motor vehicles.
- <u>Wet or muddy road</u>: all roads are closed when conditions are wet or muddy.
