# Yellowtail Wildlife Habitat Management Area

Open <u>April 20th - May 31st</u> for the take of Wild Turkey

during specific seasons as published in the 2024 Game and Fish Commission Regulations

## **GENERAL RULES:**

- Each hunter must possess a valid HMA permission slip while in the field
- Each hunter must display a valid vehicle pass in the window
- Vehicles allowed on DESIGNATED roads only (see map)
- Park only on DESIGNATED parking areas (see map)
- Leave gates as you find them
- Non-hunting, non-permitted persons may accompany a permitted hunter given that they are not hunting themselves
- No person shall possess hay, straw, grain, seed or mulch that does not have weed free certification.
- Camping allowed is established areas. No person shall camp in excess of the posted camping limit, and in no case more than fourteen (14) consecutive days, or leave a camp unattended for more than forty-eight (48) hours

### **RESTRICTIONS**

- Driving on closed roads or behind closed area gates is not allowed
- Temporary portable blinds may be used but: shall not be placed or erected more than seven (7) days prior to the opening date, and removed no more than seven (7) days following the close of the hunting season and must be marked with name and address of the person who placed or erected the structure
- Any commercial activity, including outfitting or guiding is not allowed
- Do not shoot in the direction of, or within 200 yards of, livestock or buildings
- Do not damage range improvements or harass livestock
- No travel through HMA to take wildlife not listed on permission slip

# **REMINDER: YELLOW TAIL WHMA IS OWNED BY WGFD**

- Landowner Coupons are not collected on Department owned land

### **DEFINITIONS:**

- <u>Take</u>: means hunt, pursue, catch, capture, shoot, fish, seine, trap, kill, or possess, or attempt to hunt, pursue, catch, capture, shoot, fish, seine, trap, kill or possess.
- **Established road**: means any road or trail that has been graded or constructed to carry motor vehicles or on which repeated motor vehicle traffic has created well defined tracks.
- **Designated road:** means only established roads that are marked with a white arrow sign as open to motor vehicles. Roads not marked with a white arrow sign are **closed** to motor vehicles.
- <u>ORV:</u> a recreational vehicle primarily designed for off-road use...(see W.S. 31-1-106 (K) (i,ii,iii) also known as ATV's, SideXSide, 4 wheeler, Quad, ETC.
