

BEAR CREEK HUNTER MANAGEMENT AREA

Open **OCTOBER 1, 2023—DECEMBER 21, 2023** for the take of **COW/CALF ELK** during specific seasons as published in the 2023 Game and Fish Commission Regulations

GENERAL RULES:

- Each hunter must possess a valid permission slip while in the field
- Each hunter must display a valid vehicle pass in the window
- Foot or horseback access is allowed
- Vehicles allowed on county roads only
- Use certified weed free hay for your horses while on the ranches
- Leave gates as you find them
- Non-hunting, non-permitted persons may accompany a permitted hunter with a valid permission slip
- GPS/Mapping Service is highly recommended to access this property

RESTRICTIONS

- No take of ANY OTHER SPECIES (including predators) or any other activities (including collecting antlers) without landowner written permission
- Preseason scouting is not allowed
- Driving on closed roads or behind closed area gates is not allowed
- Blinds or tree stands (temporary portable blinds may be used, but must be removed each day) are not allowed
- Any commercial activity, including outfitting or guiding is not allowed
- Do not shoot in the direction of, or within 100 yards of, livestock or buildings
- Do not damage range improvements or harass livestock
- No travel through HMA to take wildlife not listed on permission slip
- No shooting in or across closed section. Access only from parking areas - No EXCEPTIONS (see map)

Bear Creek Ranch specific rules:

- Some pastures or areas may be posted closed to hunting for certain periods of time because of livestock presence
- No take (hunting) on pivot, south of county road 6NS
- Park only in DESIGNATED parking areas

AFTER HARVEST:

- Please fill out carcass coupon and landowner coupon. If harvested on deeded land, please deposit the landowner coupon in any coupon box on HMA or mail to appropriate landowner.

- Blood Samples: Hunters are reminded that the Department is conducting brucellosis testing on elk. Hunters need to collect a blood sample and submit it for testing.
- CWD Samples: Hunters are reminded the Department is collecting CWD samples from deer and elk.

DEFINITIONS:

- **Take:** means hunt, pursue, catch, capture, shoot, fish, seine, trap, kill, or possess, or attempt to hunt, pursue, catch, capture, shoot, fish, seine, trap, kill or possess.
