

## HANNA DRAW WEST HUNTER MANAGEMENT AREA-

Open November 1, 2023 thru November 30, 2023 for the take of **Antlerless Elk** in hunt area 16 during specific seasons as published in the 2023 Game and Fish Commission Regulations

### GENERAL RULES:

- Each hunter must possess a valid permission slip while in the field
- Each hunter must display a valid vehicle pass in the window
- Foot or horseback access is allowed
- Use certified weed free hay for your horses while on the ranches
- Leave gates as you find them.
- Non-hunting , non-permitted persons may accompany a permitted hunter with a valid permission slip and do not possess a firearm
- GPS/Mapping Service is highly recommended when accessing this property
- **No littering**—carry out everything you bring in.

### RESTRICTIONS

- No take of ANY OTHER SPECIES (including predators) or any other activities (including collecting antlers) without landowner permission
- Preseason scouting is not allowed
- Access within closed areas (see map) is not allowed
- Driving on closed roads or behind closed area gates is not allowed
- Use or construction of blinds prohibited.
- Any commercial activity, including outfitting or guiding is not allowed
- Do not shoot in the direction of livestock, roads, stock tanks, windmills or buildings.
- Do not damage fences, range improvements or harass livestock
- No Overnight Camping.
- No travel through HMA for the take of wildlife not listed on permission slip
- No dogs allowed

### Hanna Draw West HMA SPECIFIC RULES:

- A hunter may only apply for one limited permission slip per species.
- One permission slip will allow a hunter who possesses multiple valid, unused Area 16 antlerless elk licenses to take multiple elk during permitted period.
- Permission slips will be issued first come, first serve basis for antlerless elk starting October 21.
- Access only during dates specified on permission slip for current year
- Drive on **established** roads only. (Watch for signs marking closed)
- Regardless of reason, there shall be **no motorized travel on reclaimed mine areas.**
- **Possession or use of ORVs, as defined in WY Statute 31-1-101(K), is prohibited.**
- Abide by all signs and posted areas.
- Remember, future hunting opportunities depend on hunter compliance with all ranch rules as well as Game and Fish laws and regulations.

- CWD samples: Hunters are reminded the Department is collecting CWD samples from deer and elk.

## DEFINITIONS:

- **TAKE:** Means hunt, pursue, catch, capture, shoot, fish, seine, trap, kill, or posses, or attempt to hunt, pursue, catch, capture, shoot, fish, seine, trap, kill or possess.
- **Established road:** means any road or trail that has been graded or constructed to carry motor vehicles or on which repeated motor vehicle traffic has created well defined tracks
- **Designated road:** means only established roads that are marked with a white arrow sign as open to motor vehicles. Roads not marked with a white arrow sign are **closed** to motor vehicles.
- **Wet or muddy road:** all roads are closed when conditions are wet or muddy.
